1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £ 300 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

I report in respect of my audit of the accounts under section 13 of the Act, whether any matters that come to my attention give cause for concern that relevant legislation and regulatory requirements have not been met. My audit has been conducted in accordance with guidance issued by the Auditor General for Wales.

Auditor General's report

Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis for Qualification

Annual Governance Statement

In my opinion, the Annual Governance Statement is inconsistent with the Council's governance arrangements for the year:

- When setting its precept, the Council is required to calculate its budget requirement in accordance with the Local Government Finance Act 1992. The Council did not prepare a budget for 2021-22. On this basis, in my opinion, the Council issued an unlawful precept.
- The Council does not publish on its website information that it is required to publish electronically by the Local Government (Democracy) (Wales) Act 2013.

Arrangements to secure economy, efficiency and effectiveness in its use of resources

In my opinion, the Council has not made proper arrangements to secure economy, efficiency and effectiveness in its use of resources:

- The Council has adopted template standing orders but has not tailored the financial thresholds to meet the needs of the Council. The standing orders as adopted mean that none of the Council's expenditure is subject to quotes or tenders.
